- Engage in the process of recovery treatment planning and create an empowering, engaging and client-centered process that allows the client to take ownership of their recovery plan.
- Meet with the client on a weekly basis, or as needed, to provide engaging support to help aid in their recovery.
- Collaborate with the client to formally review the recovery treatment plan every 90 calendar days.
